Notes on ordering Dual Roller Clutch-Operated FlexShade:

Control location determined by viewing shade from inside the room. Right side standard.

Orders with fascia are automatically furnished with endcaps instead of brackets.

Aluminum slat encased in heat sealed hem.

Metal bead chain standard. Control length will be cut to standard length by Draper.

Chain Length will be 6" less than overall shade height unless specified otherwise.

Draper does not provide fasteners. It is installer's responsibility to select appropriate fasteners.

*IM - Inside Measure. Draper makes a 1/8" deduction.

*OM - Outside Measure. No deductions made: widths shown is overall dimension include brackets or endcaps.
